★ For Whom Is The Air Cargo Course Intended?

The course has been designed primarily for the operations staff of international air cargo agents but will also be useful to:

- All sales and marketing staff of cargo agents and air freight forwarders (consolidators);
- ☐ The sales, reservations, and acceptance staff of airlines, airport handling, and surface transportation companies;

- A Shipping department staff of manufacturers, wholesalers, importers, and exporters; and
- Junior and middle management staff of cargo agents, airlines, and manufacturers who wish to expand or refresh their knowledge of current international air cargo rating procedures.

★ Course Contents

The course is based on current industry tariffs and publications. It covers the following subjects and objectives:

☐ Unit 1 – Industry Regulations

Upon completion you will understand the role and functions of:

- ICAO;
- National Aviation Authorities;
- IATA; and
- FIATA;

☐ Unit 2 – The Air Cargo Agency

This unit consists of the following sections:

- The IATA cargo agent;
- The consolidator;
- Operations;
- Service functions;
- Organisations;
- Liability.

This unit enable you to understand the difference between an IATA cargo agent and a consolidator, their respective functions and the relationship between the air cargo agent and his customers, on one hand, and the airline on the other.

→ Unit 3 – World Geography

The unit consists of the following sections:

- Geography and IATA 3-letter codes of cities and airports;
- Time differences;
- Calculation of transportation time.

You can expend your expertise by consulting a complete edition of The Air Cargo Tariff (TACT) Rules, Section 7 - Information by Countries, where all customs airports for each country are listed.

After studying this unit you will be able to name and locate countries and principal cities worldwide, apply correctly the IATA 3-letter city and airport codes and understand the time differences and calculate times between any given points, and transportation time of a flight.

尽 Unit 4 − Use of Guides

This unit provides a survey of the guide used in air cargo transportation and it describes its structure and presentation. The subject matter of this unit and unit 5 and 6 are essential for unit 7 "Air Cargo Acceptance" in which the subjects of all three units will be applied to specific areas.

Upon completion of this unit, you will be able to use the guides and construct unpublished transfer connections for air cargo shipments.

✓ Unit 5 – Aircraft

This unit describes some of the physical characteristics of current aircraft types used in the transportation of cargo and the effects of these characteristics on the acceptance of cargo because of their weight dimensions and weight. After completion of this unit, you will be able to describe aircraft characteristics; use the loading charts reproduced in Section 8.2 of the TACT Rules and list the different types of Unit Load Devices (ULD) together with their weight and volume restrictions.

✓ Unit 6 – Handling Facilities

At the end of this unit you will be able to list the most common equipment and facilities for air cargo and aircrafts handling, customs clearance, storage and loading/unloading facilities for different airports by using TACT Rules, Section 7.

☐ Unit 7 – Air Cargo Acceptance

This unit emphasises the various factors which must be taken into consideration when accepting a shipment for carriage by air by fulfilling "ready for carriage" condition. It covers;

- Instruction for carriage;
- Acceptance based on the Shipper's Letter of Instruction (SLI);
- Acceptance of special cargoes.

At the end of this unit, you will be able to make cargo booking with airlines in accordance with the applicable IATA rules and procedures.

→ Unit 8 – Cargo Booking Procedure

This unit introduces you to airline booking systems and procedures. It tells you why, how and when a booking should or must be made.

At the end of this unit, you will be able to make cargo bookings with airlines in accordance with the applicable IATA rules and procedures.

⊘ Unit 9 – Cargo Automation

After going through this unit, you will be to list the main functions of SITA and to give a general description of Cargo-IMP, EDI, UN/EDIFACT, CCS, CARGO 2000 and e-freight.

⊘ Unit 10 – Air Cargo Rates and Charges

This unit covers:

- The Air Cargo Tariff (TACT);
- IATA's geographical areas and sub-areas;
- The Chargeable weight;
- Currencies;
- Rates and charges;
- General rules;
- Minimum charges;
- General cargo rates (GCR)
- Specific commodity rates (SCR)
- Class rates;
- The lower charge in higher weight category principle;
- Precedence of rates and charges;
- Valuation charges;
- Charges collect shipments;
- Disbursements;
- Other charges and fees.

This is the largest unit of the training programme and requires the longest study time. In this unit you will learn how to apply published rates to normal consignments, based on the use of TACT Rules and Rates.

After completion of this unit, you will be able to identify IATA's areas and sub areas. Further on you will be capable to apply the through rates and charges, based on the IATA resolutions to normal cargo shipments as published in the TACT.

✓ Unit 11 – Air Waybill

This unit teaches you how to correctly complete air waybills (AWB) for the different types of commodities covered in this introduction in air cargo training. The unit covers:

- The airlines air waybill;
- The neutral air waybill;
- Functions of the airline and neutral air waybill;
- Completion of the airline and neutral air waybill;
- Labelling and marking.

An accurately completed air waybill is the final aim of the instruction contained in this course. At the end of this unit you will be able to complete air waybills in accordance with IATA resolutions for the type of shipments covered in this course.

★ Examination Procedures

- → Students are allowed 2 attempts to pass the examination within the 18-month enrolment period.
